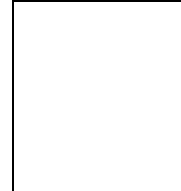

IT IS HEREBY AGREED THAT:

A. TUITION, MISCELLANEOUS AND OTHER SCHOOL FEES

Tuition, miscellaneous and other school fees shall be paid in strict accordance with the schedule of payments. Tuition, miscellaneous and other school fees for the entire course are deemed incurred upon enrollment. A student may only start his/her training upon payment of school fees.

Student withdrawal, for any reason, shall be charged 30% penalty/surcharge if done within three (3) days after receipt of payment and 100% if withdrawal is made after 3 days. Cash payment scheme unpaid on due date will be automatically converted to the Installment scheme and rate.
